Verifiers confirm they have seen ID documents for people applying for criminal record checks. All area and local meeting clerks, co-clerks and assistant clerks are listed as verifiers (for the period of their appointment). Additional verifiers can also be appointed by meetings. Please check that you have sent us your meeting's latest clerking/verifier appointments. We will add these to the verifier list which is sent, at the end of each month, to CAS who process our DBS forms and each appointee is included as a verifier from the start of the following month.
